This Authorized Dealer Agreement is made as of the Effective Date (as defined on the signature page) between DSC Sport LLC, a Maryland corporation, hereinafter referred to as DSC Sport, and the Authorized Dealer, defined as above, and located at the address as shown above, hereinafter referred to as Dealer.

1. **Appointment.** Subject to the terms and conditions of this Agreement, DSC Sport appoints the Dealer and the Dealer agrees to perform as DSC Sport's Nonexclusive Authorized Dealer for the Products during the Term of this Agreement. For definitions of capitalized terms, see Section XXIII of this Agreement.
2. **Responsibilities** of the Authorized Dealer. Except as otherwise approved in writing by DSC Sport in advance, the Dealer agrees to perform each of the following:
  - (a) Use its best efforts to market and promote the sale and use of DSC Sport's products, and agrees that its marketing and advertising efforts will be of high quality, in good taste, and will preserve the professional image and reputation of DSC Sport and DSC Sport products.
  - (b) Will include in all its advertisements, brochures and other marketing materials referring to DSC Sport, or a DSC Sport product, all applicable copyright and trademark information. The Dealer will also use the colors, fonts, logos and other details as contained in the DSC Sport Style Guidelines, to be provided to them by DSC Sport. DSC Sport will provide a reasonable amount of advertising material, as requested by the Dealer, for use in the Dealer's efforts to market DSC Sport's products.
  - (c) Advertise and promote DSC Sport's products in accordance with DSC Sport's Minimum Advertised Pricing (MAP) Policy, or at or above MSRP in absence of MAP Policy.
  - (d) Represent and sell DSC Sport's products in an ethical and professional manner and refrain from any conduct that is, or could be, detrimental to the reputation and/or integrity of the Dealer and DSC Sport.
  - (e) Promptly and effectively respond to questions and service requests from customers and prospective customers, or if unable to answer the questions or service requests, promptly refer the customer to DSC Sport for resolution of the question or service request.
  - (f) Use any Intellectual Property only as permitted by DSC Sport.
  - (g) Refrain from questioning or challenging the rights claimed by DSC Sport or its Affiliates in the Intellectual Property, or assisting in any way any other(s) in doing so.
  - (h) Comply with all laws and all of the DSC Sport's Policies.
  - (i) Promptly and in timely fashion comply with whatever request may be made by DSC Sport, relating to any law or expectation thereof, of the modification or recall of any or all of DSC's products.
3. **Notices.** Each notice described in this Agreement to either Party must be in writing and shall be sent to the intended recipient (with all fees paid) by certified mail, express courier service, FAX, or E-Mail to such recipient's address referred to on the first (1st) page of this Agreement and shall be considered effective or received when actually received or refused by such recipient, provided that the sending Party has written confirmation thereof, and such refusal was not due to electronic or mechanical malfunction or failure.
4. **Pricing.** Except as otherwise approved in writing by DSC Sport, the Dealer will advertise all DSC Sport products at the specified MSRP, as defined by DSC Sport.



5. **Shipments.** All shipments will be made FOB Jessup, MD. Delivery will be deemed complete, and risk of loss or damage to the DSC Sport products will pass to the dealer upon delivery to the carrier, if the product(s) is/are shipped via the Dealer's carrier. If DSC Sport's carrier is used, any and all damage will be covered by DSC Sport.
6. **Payment.** Payment for DSC Sport products ordered from DSC Sport and shipping costs shall be due at the time of the order by check or other means satisfactory to DSC Sport. DSC Sport may, at its sole discretion, grant credit approval, in which case all payments shall be due within 30 days after the date of DSC Sport's invoice. The invoice date shall be before the actual date of shipment. All sums not paid when due shall accrue interest daily at the less of an annual rate of 18%, or the highest rate permissible by law on the unpaid balance until paid in full. Until paid in full, DSC Sport shall remain the lienholder of DSC Sport products. DSC Sport reserves the right to terminate or modify the terms of credit payments when, at its sole discretion, DSC Sport believes that its payment may be at risk.
7. **Taxes.** In addition to any payments due to DSC Sport under this agreement, the Dealer shall pay amounts equal to any taxes or other amounts, including state sales taxes, however designated, which are levied or based upon such payments, or upon this Agreement. Dealer agrees to provide DSC Sport with a state resale certificate, if required by state law.
8. **Termination.** This agreement will terminate when either Party provides the other Party with written notice of termination, and such termination shall be effective: (a) no sooner than the date of receipt of such notice in the event of a material breach of this Agreement by such other Party; (b) no less than forty-five (45) days after such receipt for termination on other grounds (which may be with or without cause); or (c) as provided in Section V(d)(ii) of this Agreement. Upon termination of this Agreement, the Dealer shall immediately cease all use of anything which would give the impression that the Dealer is an Authorized Dealer or Representative of DSC for the Products, or has any affiliation whatsoever with DSC Sport or DSC Sport's products (except for the Dealer's inventory of DSC products at the time of termination).
9. **Items Surviving After Termination.** The following items shall survive the termination of this Agreement: Section I, Sections II(c), II(e), and II(f), Section XXIII, and each of the DSC Sport Policies which by its own terms expressly states that it survives the termination of this Agreement, or which DSC Sport otherwise designates as so surviving.
10. **DSC Sport Retail Sales and "Double-Teaming".** DSC Sport reserves the right to conduct retail sales of Products in all areas. Dealers are not granted exclusivity for their area, region or state. We encourage each dealer to weekly send DSC Sport a list of customers with whom the Dealer is communicating concerning the pending sale of Products. This practice helps prevent "double-teaming" of a potential customer by both DSC Sport and the Dealer. Each Dealer should document their initial contact with a prospective customer via an E-Mail sent to the customer containing any prices and other details that were provided. When accidental "double-teaming" does occur, the sale will be assigned to either the Dealer or DSC Sport, depending on the E-Mail documents which both the Dealer and DSC Sport have saved for reference. The sale should be credited to whichever party can document the earliest contact with the potential customer. Careful, concise documentation and effective communication with DSC Sport will ensure that "double-teaming" is kept to a minimum.
11. **No Agency and No Franchise.** This agreement, and any and all duties and obligations hereunder may not be delegated, transferred or assigned by the Dealer without the express written consent of DSC Sport. Each delegation, transfer or assignment by the Dealer without such consent shall be void. The relationship between DSC Sport and the Dealer shall be that of independent contractors, and nothing in this Agreement shall constitute or be deemed to constitute a partnership, joint venture or franchise between DSC Sport and the Dealer, or shall constitute or be deemed to constitute the Dealer as an agent of DSC Sport for any purpose whatsoever. The Dealer shall have no authority or power to bind DSC Sport, or to contract in the name of, and create a liability against, DSC Sport for any purpose whatsoever.
12. **Modification of DSC Sport Policies.** At any time, and without prior notice: (i) DSC Sport may modify any or all of the DSC Sport Policies and (ii) any or all item(s) of the Products may change, in which case, the Dealer acknowledges and agrees that DSC Sport may, without liability or penalty, cancel all pending orders (even if accepted) from the Dealer, for such changed item(s) and refuse to accept any new orders from the Dealer for such item(s). Except as otherwise expressly provided in this Agreement, each modification of the DSC Sport Policies shall be effective immediately, unless DSC Sport notifies the Dealer in writing of another effective date. DSC Sport's interpretation of each of the DSC Sport Policies will control.



13. **Warranty Limitation and Disclaimer.** EXCEPT FOR THE EXPRESS WARRANTIES SET FORTH IN DSC SPORT'S CUSTOMER OR OTHER INFORMATION, DSC SPORT MAKES NO OTHER WARRANTIES RELATING TO THE DSC SPORT PRODUCTS EXPRESS OR IMPLIED, AND EXPRESSLY EXCLUDES ANY WARRANTY OF NONINFRINGEMENT, FITNESS FOR A PARTICULAR PURPOSE, OR MERCHANTABILITY. NO PERSON IS AUTHORIZED TO MAKE ANY OTHER WARRANTY OR REPRESENTATION CONCERNING THE PERFORMANCE OF DSC SPORT PRODUCTS, OTHER THAN AS PROVIDED IN THIS SECTION AND IN THE DSC SPORT PROMOTIONAL INFORMATION. RESELLER SHALL MAKE NO OTHER WARRANTY, EXPRESS OR IMPLIED, ON BEHALF OF DSC SPORT.
14. **Indemnification.** The Dealer shall indemnify and hold DSC Sport harmless from any claims or damages (inclusive of DSC Sport's attorney's fees) made against DSC Sport as a result of negligence, misrepresentation, error or omission on the part of the Dealer or its representatives. The Dealer shall be solely responsible for any claims, warranties or representations made by the Dealer or the Dealer's employees or agents that differ from the warranty provided by DSC Sport in any of its promotional or marketing information.
15. **Controlling Law and Forum.** This agreement shall be governed in all respects by the laws of the State of Maryland, as such laws are applied to agreements entered into and to be performed entirely within Maryland and by Maryland residents. All disputes arising under this Agreement shall be brought in Superior Court of the State of Maryland or Federal District Court as permitted by law.
16. **Consequential Damages Waiver.** DSC Sport shall not be liable for loss, damage, or delay resulting from any cause whatsoever beyond its reasonable control. In no event shall DSC Sport be liable for consequential, incidental, or special damages, loss, or expense to any or all of the Dealer, purchaser(s) or person(s) for any reason(s) whatsoever. In the event of any conflict between the DSC Sport Policies and this Agreement, the DSC Sport Policies will control. Wherever required by the context hereof, each pronoun used herein shall be deemed to include both the singular and the plural and to encompass each gender.
17. **Conflict of Law and Severability.** If applicable law contains any requirement that is contrary to, conflicts with, or is missing from any provision(s) or part(s) thereof in this Agreement, DSC Sport, at any time, may elect by written notice to the Dealer (effective upon receipt thereof or as otherwise designated by DSC Sport therein) that: (i) such requirement be substituted for or added to such provision(s) or part(s) thereof to the minimum extent necessary to validate such provision(s) or part(s) thereof or (ii) this Agreement be terminated. If any provision(s) or part(s) thereof in this Agreement shall be held invalid, the remainder of this Agreement shall continue in full force and effect, and each such provision or part thereof shall be deemed not to be part of this Agreement.
18. **Waiver.** Except as otherwise provided in this Agreement or as the Parties otherwise may expressly agree in writing, no failure, refusal, neglect, delay, waiver, forbearance, or omission by DSC Sport to exercise any right(s) under this Agreement or to insist upon full compliance by the Dealer with the Dealer's duties, obligations, or restrictions hereunder shall constitute a novation or waiver of any provision(s) of this Agreement, or otherwise thereafter limit DSC Sport's right to fully enforce any or all of the other provision(s) and part(s) of this agreement.
19. **Entire Agreement.** This Agreement and each of the DSC Sport Policies, as modified from time to time: (i) Constitute the entire understanding of the Parties binding upon them; (ii) Are intended to govern the relationship between the Parties; (iii) Supersede all agreements, representations, or statements between the Parties, either oral or written; and (iv) Except as otherwise provided herein, may be amended or modified only by a written supplement, duly executed by both of the Parties.
20. **Voluntary Agreement.** This Agreement was negotiated and executed voluntarily, and is not the result of duress, fraud, undue influence, or any threat of any kind. All parties had the opportunity to read and consider this Agreement, to consult with counsel, and fully understand the Agreement.
21. **Force Majeure.** DSC Sport is entitled to invoke Force Majeure if the implementation of this agreement is, in whole or in part, temporarily or not, prevented or impeded by circumstances out of its control, including site or building blockades, strikes, wars, embargoes, specific work interruptions or slowdowns or lockouts, delay in the provision to DSC Sport or its Affiliates of parts, goods or services ordered from third parties, accidents, interruptions of business operations, and Acts of God. In the case of Force Majeure, DSC Sport's obligations will be suspended. The Force Majeure provisions are not applicable to the payment of any amounts owed when due.



22. **Certain Definitions.** For the purposes of this Agreement, the following definitions shall apply:

- (a) Nonexclusive Authorized Dealer shall be defined as (i) the Dealer may hold itself out as a dealer authorized by DSC Sport to sell the Products during the Term and (ii) DSC Sport may offer and sell anywhere and everywhere any or all of the Products, and anything else directly or indirectly to one or more individuals and entities other than the Dealer and (iii) the Dealer may sell the Products only to consumers for personal use and not to other Dealers or resellers not specifically authorized by this agreement.
- (b) "The Products" shall be defined as those products made available to the Dealer directly from DSC Sport or by any or all warehouse distributors specifically authorized by DSC Sport to sell to the Dealer (individually, an "Authorized Distributor" and collectively, the "Authorized Distributors").
- (c) "The Term" shall be defined as the period from the Effective Date until this Agreement is terminated pursuant to Section IX hereof.
- (d) "The Intellectual Property" shall be defined as any or all of the patents, designs, trademarks, service marks, trade names, commercial symbols, copyrights, data, databases, market information, trade secrets, and confidential information in which DSC Sport or its Affiliate(s) claim(s) rights.
- (e) "Affiliate(s)" shall be defined as any or all of the individual(s), entity and entities controlling, controlled by, or under common control with the Party Identified.
- (f) "DSC Sport Policies" shall be defined as collectively the then-current version(s) of the announcements and policies (whether in the form of correspondence, memoranda, notices, or otherwise) from time to time issued in writing or made available electronically by DSC Sport to the Dealer and not expressly excluded by DSC Sport from the DSC Sport Policies. For the purposes of this Agreement, "Party" means DSC Sport or the Dealer and "the Parties" means DSC Sport and the Dealer.

**Each Party, intending this Agreement to be effective as of the Effective Date, has caused this agreement to be executed by the duly authorized representative listed below.**

## DSC Sport Limited Warranty

DSC Sport, LLC, located at 8040 Washington Boulevard, Jessup, MD 20794, warrants to the original retail purchaser that each new DSC Sport product listed below and purchased either directly from DSC Sport, or from an authorized DSC Sport dealer, shall be free from defects in material and workmanship for the period of time listed below, starting from the date of purchase, when used on private passenger cars for personal use and under normal operating conditions. Normal operating conditions include use for HPDE, track days, and club racing, but exclude professional racing events or series. Products installed on professional racing vehicles will be considered on an individual basis.

Warranty Period	Covered DSCsport Products
1 Year	All DSCsport Products. For an item to be considered a DSCsport Product, the official DSCsport logo must be physically and visibly attached to the outside of the covered product. One year warranty against manufacturing defects for street operation applications. No warranty for racing and competition due to the harsh operating environment. Warranty covers DSCsport product(s) only, does not cover any consequential items. In order to qualify for warranty user must register their product online(DSCsport.com/Warranty) within 30 days of purchase. There are no refunds only repair or replacement of products.

**Warranty Coverage:** This warranty covers defects in material and workmanship in the covered DSC Sport products listed above. DSC Sport's sole and exclusive obligation, and the original retail purchaser's sole and exclusive remedy under this warranty, is limited to the exchange/replacement of a defective covered DSC Sport product in accordance with this Limited Warranty.

**Making a Warranty Claim:** In order to make a warranty claim for an allegedly defective DSC Sport product, the original retail purchaser shall perform the following:

- (a) Provide the original sales receipt, listing a valid DSC Sport part number for a covered product, to either the DSC Sport dealer from which the product was purchased, or to DSC Sport, if the product was purchased directly.
- (b) The DSC Sport product must be send in for inspection to verify that the product qualifies for a replacement/exchange under the terms of this warranty. The inspection and verification is provided free of charge to the original retail purchaser.
- (c) To have the product inspected and verified, the original retail purchaser must return the allegedly defective DSC product to the original point of purchase, along with the original sales receipt, or a valid copy, as described in Step (a). If the original point of purchase no longer exists, or for any other reason the original retail purchaser is unable, despite good faith efforts, to return the product to the original point of purchase, then the original retail purchaser shall return the allegedly defective DSC Sport product to either another DSC Sport dealer, or directly to DSC Sport, along with the original sales receipt, or a valid copy.
- (d) Warranty claims will only be honored for the DSC Sport products listed in the table above, and not otherwise excluded by this Limited Warranty.
- (e) If the provisions of this limited warranty are met, and the product is determined to be defective, and qualifies for replacement/exchange, the product will be replaced/exchanged with a new unit of the same, or superseded DSC part number. In the case of a DSC Sport product being superseded, the replacement part must be stated in the product section of the DSC Sport website.
- (f) Installation, shipping, removal and/or diagnostics are not included in this limited warranty



## **Warranty Coverage Exclusions:**

The DSC Sport Limited Warranty does not apply to DSC Sport products that are:

- (a) Worn, but are not defective.
- (b) Do not qualify due to the expiration of the warranty time period specified in the table above for each product.
- (c) Are installed for an application not listed in this warranty.
- (d) Are purchased from any entity other than an authorized DSC Sport dealer, or DSC Sport itself.
- (e) Are altered, modified, reworked, improperly applied or installed, or abused.
- (f) Are installed on a vehicle used for commercial purposes.
- (g) Are damaged due to vehicle modifications or an accident.
- (h) Are installed on a Professional racing vehicle and were deemed not covered on an individual basis.

The cost of any diagnostics, the removal of the defective DSC Sport product, or the replacement of the defective DSC Sport product, is not included in this warranty. The cost of shipping the alleged defective DSC Sport product back to the dealer or to DSC Sport, or the cost of shipping the replacement DSC Sport product to the customer or the DSC Sport dealer, is also not included in this warranty.

**Warranty Limitations:** DSC SPORT'S LIMITED WARRANTY IS IN LIEU OF AND EXCLUDES ALL OTHER WARRANTIES, EXPRESS, IMPLIED, STATUTORY OR OTHERWISE CREATED UNDER APPLICABLE LAW, PROVIDED HOWEVER, THAT ANY IMPLIED WARRANTY, WARRANTY OF MERCHANTABILITY, AND ANY WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE LIMITED WARRANTY PERIODS SET FORTH HEREIN FOR THE COVERED DSC SPORT PRODUCTS. DSC SPORT SHALL NOT BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES AS THE RESULT OF ANY FAILURE IN MATERIAL OR WORKMANSHIP OF A DSC SPORT PRODUCT.

DSC SPORT'S LIMITED WARRANTY GIVES THE CUSTOMER CERTAIN LEGAL RIGHTS, AND THE CUSTOMER MAY HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE. SOME STATES DO NOT ALLOW THE LIMITATIONS OF IMPLIED WARRANTIES OR THE EXCLUSION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO ALL CUSTOMERS. ## **Warranty Transferability:**

This warranty is not assignable or otherwise transferable to any subsequent purchaser or user of the covered DSC Product, and any sale or other transfer of the product shall void this warranty, and DSC Sport shall have no further obligation or liability with regards to the DSC Product. Dispute Resolution Will Occur Through Binding Arbitration: Any disagreement, dispute, controversy or claim arising out of or relating to this Limited Warranty or the DSC Sport products, must be brought in the original retail purchaser's capacity and shall be settled by binding bilateral arbitration, located in Maryland, before one arbitrator, in accordance with the rules of the American Arbitration Association (AAA) and the

Federal Arbitration Act (FAA). The original retail purchaser shall not be able to bring a lawsuit for any dispute relating to the covered products. Instead, the original retail purchaser must submit any and all disputes through the AAA, which includes mandatory bilateral arbitration that is binding on both DSC Sport and the purchaser. Judgement upon the award rendered by the arbitrator, may be entered in any court having jurisdiction thereof. Absent a separate, signed written agreement between DSC Sport and the original retail purchaser, no class arbitration is permitted, and the original retail purchaser is prohibited from acting as a class representative, or as a member of any class of claimants pertaining to any claim subject to arbitration. Nor shall the original retail purchaser's claim be joined by any other person's claim, or the original retail purchaser act directly or indirectly as a representative on behalf of any other person's claim.
